

## **Terms and conditions**

### **Invested in the economic powerhouses of Asia**

**Promotion Period: 24 March 2025 to 23 May 2025**

#### **PART A. ABOUT THE PROMOTION**

1. Invested in the Economic Powerhouses of Asia (“Promotion”) is run by Eastspring Investments Berhad (“Organiser”) and is open for eligible investors (“Investors”).
2. The Promotion starts at 12am on 24 March 2025 and ends at 4pm on 23 May 2025 (“Promotion Period”) and is applicable to transactions initiated and completed through myEastspring (Website and/or mobile app) system only.
3. To participate in the Promotion, Investors must complete the following steps:
  - 3.1. Open a cash investment account via the myEastspring mobile app;
  - 3.2. Make a minimum investment of RM1,000 in Eastspring Investments Dragon Peacock MY Fund and/or Eastspring Investments Asia Select Income Fund; and

4. Only confirmation emails from the MyEastspring system are considered acceptable proof of submitted investment. Any other proof of submitted investment does not constitute evidence that the Organiser has received the Promotion entry or that the Investors have participated in the Promotion.
5. The Organiser reserves the right to substitute the Reward with any other item(s) of similar value at its discretion. Any further correspondence will not be entertained.
