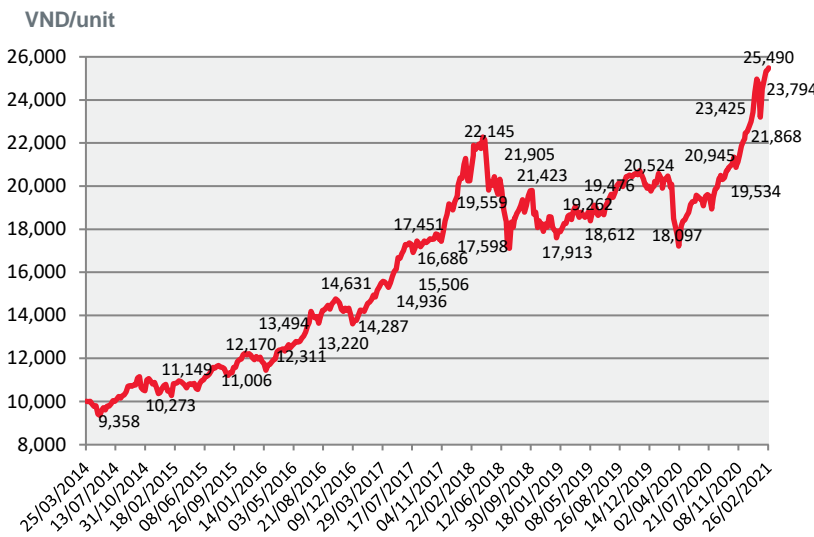

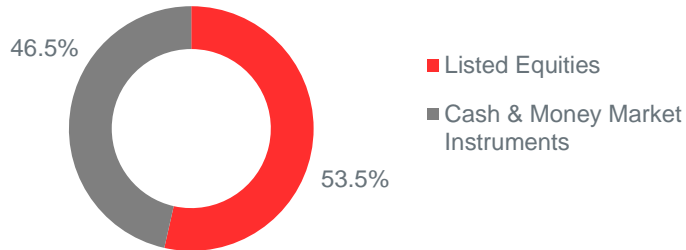
### PERFORMANCE CHART – NAV
