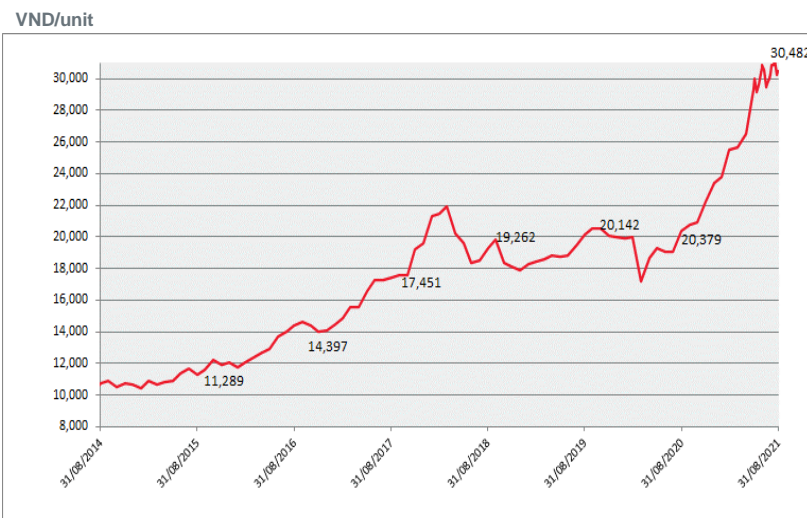

### PERFORMANCE CHART – unit NAV



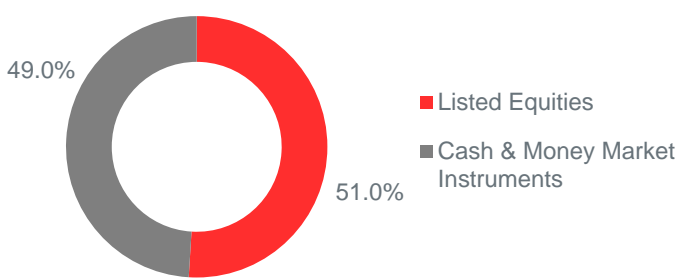
