THE FIRST AMENDMENT TO THE CHARTER

OF

WHEREAS

- (A) Eastspring Investments Fund Management Limited Liability Company (the “**Company**”) was originally established under License on operation of fund managements No. 03/KDBH-GPHĐQLQ dated 26 May 2005 and its amendment from time to time, including the Amended License for Establishment and Securities Business Operation No. 34/GPDC-UBCK dated 30 June 2025;
- (B) Pursuant to Securities Law No. 54/2019/QH14 dated 26 Nov 2019, Law on Amendments to Law on Securities, Law on Accounting, Law on Independent Audit, Law on State Budget, Law on Management and Use of Public Assets, Law on Tax Administration, Law on Personal Income Tax, Law on National Reserves, and Law on Handling of Administrative Violations No. 56/2024/QH15 dated 29 November 2024, and its implementation regulations;
- (C) Pursuant to Law on Enterprises No. 59/2020/QH14 dated 17 June 2020, Law on Amendments to Law on Enterprises No. 76/2025/QH15 dated 17 June 2025, and its implementation regulations;
- (D) Pursuant to the Charter of the Company dated 18 Oct 2022 (the “**Charter**”).
- (E) Demand for change of registered head office of EIVN.

Now, therefore, it’s agreed as follows:

1. AMENDMENT TO THE LEGAL ADDRESS AND MAILING ADDRESS OF THE COMPANY OWNER IN ARTICLE 4.1

- 1.1. The registered head office of the Company Owner in Article 4.1 of the Charter shall be amended as follows:

- 2.1 This First Amendment is executed in three (3) originals in English and three (3) originals in Vietnamese. In case of any discrepancy between the two languages, the English one shall prevail.
