DISTRIBUTION FOR EASTSPRING INVESTMENTS UNIT TRUSTS – SINGAPORE SELECT BOND FUND CLASS A_D

Thank you for your subscription in Eastspring Investments Unit Trusts – Singapore Select Bond Fund (the "Fund").

With effect from 1 August 2017, the distribution frequency for Class A_D of the Fund is changed from annual to quarterly basis.

For the first quarterly distribution payout, we are pleased to inform that the Fund intends to make a distribution payout of **S\$0.0092107 per unit for Class A_D^{-1}**. Investors who are invested as at the record date of 29 September 2017 will receive the distribution payout that may be made.

The Fund aims to maximise total returns over time by investing primarily in Singapore-dollar denominated debt securities and foreign currency debt securities which will be hedged back into Singapore Dollars. It is suitable for investors who seek long term total returns through bonds.

The Fund is managed by a dedicated and experienced fixed income team with an average of 14 years investment experience² which has won several best-in-class awards over the years³. The Fund (Class A_D) is rated 5-star in Morningstar's Overall Rating category⁴.
