

Eastspring Investments - Asia ESG Bond Fund (the "Fund")



- Eastspring Investments - Asia ESG Bond Fund is referred to as the 'Fund'.
- The Fund invests in fixed income/debt securities and is subject to interest rate fluctuation and exposed to credit default, valuation and credit rating risks as well as credit risk of the counterparties with which it trades and sovereign debt risk. Pertaining to investments in unrated/non-investment grade fixed income/debt securities/non-investment grade sovereign fixed income/debt securities, these securities may be subject to higher credit risks and liquidity risks, compared with investment grade fixed income/debt securities, with an increased risk of loss of investments. The Fund seeks to maximize total returns over time through investing at least 70% of its assets in debt securities denominated in US dollars, Euro, as well as the various Asian currencies which are issued or guaranteed by Asian governments and quasi-governments, or corporates or supranationals that are aligned to Eastspring Environmental, Social and Governance ("ESG") principles ("Eastspring's ESG Principles"), including Green, Social, Sustainability ("GSS") labelled bonds.
