The investments of the Fund include, but are not limited to, listed securities in the Recognised Markets, depository receipts including ADRs and GDRs, debt securities convertible into common shares, preference shares and warrants. Recognised Markets mean a regulated market, which operates regularly and is recognised and open to the public.
