The Fund invests primarily in securities of companies, which are incorporated, listed in or have their area of primary activity in Asian excluding Japan.

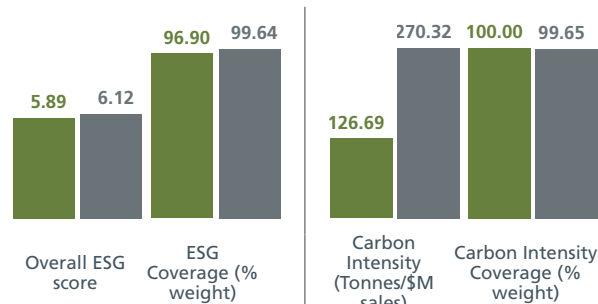
