Strategy overview

The Fund invests in a diversified portfolio consisting primarily of fixed income / debt securities issued by Asian entities or their subsidiaries. The Fund's portfolio primarily consists of securities denominated in the various Asian currencies and aims to maximize total returns through investing in fixed income / debt securities that are rated as well as unrated. The team employs a dynamic investment approach as well as a rigorous credit research process that focuses on fundamental, valuation and technical factors.
