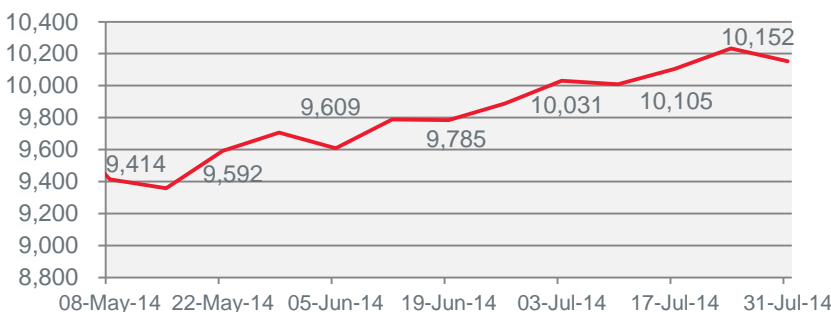

PERFORMANCE CHART – NAV

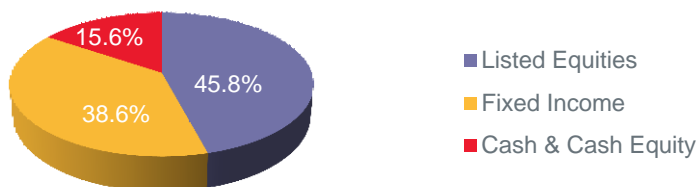
